

BusyBz Cleaning Co. – Website Terms and Conditions

These Terms and Conditions (“Terms”) govern your access to and use of the website located at <https://www.busybzcleaningco.com> (the “Site”), operated by BusyBz Cleaning Co. These Terms govern use of the Site only. They do not constitute, and are not intended to replace, the separate service agreement (including any Master Service Agreement or work order) that governs the cleaning and facilities support services BusyBz provides to its clients. In the event of any conflict between these Terms and a signed service agreement, the signed service agreement controls with respect to the services themselves.

1. Use of the Site

The Site is provided to give visitors information about BusyBz's cleaning and facilities support services and to direct visitors to request quotes or book services. You agree to use the Site only for lawful purposes and in accordance with these Terms. You agree not to:

BusyBz does not control, and is not responsible for, the operation, availability, or security of the Booking Platform, including any errors, outages, or payment processing issues that occur on that platform. Any dispute regarding a charge, booking malfunction, or payment processed through the Booking Platform should first be directed to BusyBz directly using the contact information in Section 9, and we will work with you to resolve it.

3. No Service Terms Created by the Site

Information on the Site, including descriptions of services, pricing ranges, and service areas, is provided for general informational purposes only and does not itself create a binding service contract. The specific scope of work, pricing, scheduling, cancellation policy, and liability terms applicable to any cleaning or facilities support service are governed exclusively by the separate

service agreement you enter into with BusyBz (whether executed in writing, through the Booking Platform, or otherwise).
